New Business:

A. Ordinance 16-001; An Ordinance amending Chapter 455, increasing purchasing authority of the Utility Commission.

RE: Utility Manager – Greg Kuhn

Kuhn explained the Utility has a few large purchases to make this year involving standard operating costs which will all be over the current \$10,000 purchasing limit for the Commission to approve. Each time they would have to come before the Council for approval. The Utility Commission has discussed this issue and would like Council to amend their purchasing authority. They are asking for an increase from their current purchasing authority of \$10,000 to \$30,000. Purchases would still have to be brought before the Utility Commission for approval but not before both entities; Commission and Council.

City Attorney commented there hasn't been an increase since 1997.

Mayor added that in 1977 the Commission's purchasing authority was \$3,000 and then in 1997 it was increased to \$10,000. Mayor originally suggested that the limit be set at \$25,000 but the Commission is asking for \$30,000.

Osborne felt \$20,000 would be a sufficient amount but did not agree with \$30,000 as the City is ultimately responsible for what happens with the Commission.

Motion to approve Ordinance 16-001; An Ordinance amending Chapter 455, increasing purchasing authority of the Utility Commission from \$10,000 to \$30,000.

Continued discussion...

Rusch did not feel the purchasing authority needed to be increased. If there were a catastrophic instance, such as a blown transformer; the Utility has back up to cover these types of instances.
