### Administrator Report – written report given.

**Administrator** advised Kevin Rusch has resigned from his duties as Alderperson to District 2, Wards 3 & 4. Administrator also mentioned plans are in the works to install a new car wash behind Witts Piggly Wiggly.

#### Police Report - written report given.

**Police Chief** informed the Department of Justice (DOJ) recently announced they will be paying for hours in which our officers put time in towards ICAC investigations (Internet Crimes Against Children).

**Kostreva** asked if he thought the DOJ would be willing to pay for another officer.

**Police Chief** did not think so at this time. He added that Officer Kuhn is currently working on several ICAC cases.

**Fire Chief** explained the department's plan to use the river as their water source during the time in which the water tower is being painted and out of service.
