#### **Old Business:**

- A. Demolition work at 409 Cherry Street.
  - 1) Use of city landfill for concrete disposal.
  - 2) Bids for demolition work.

Re: Street Superintendent / City Attorney

City Attorney explained when we went out for bids on demolition work at 409 Cherry Street, concrete disposal was not discussed as to whether or not contractors could use the city landfill. A letter was sent to contractors asking them to submit 2 bids; one with concrete disposal at the city landfill and another for concrete disposal using their own means. The question we need answered before approving quotes is whether or not contractors will be allowed the use of the city landfill for concrete disposal.

**MOTION:** Kostreva / Wirtz

Motion to allow the awarded contractor permission to utilize the city landfill for concrete disposal from the demolition work at 409 Cherry Street.

Voice Vote: All present voting aye -MOTION CARRIED

Quotes were received back from 4 contractors to complete demolition work at 409 Cherry Street. Quotes using the city landfill for concrete disposal were as follows:

Landis Excavating LLC \$11,555.
Duame Sand & Gravel Inc \$18,645.
Thomson Excavating \$20,371.
KCG Excavating & Material Inc \$24,070.

**City Attorney** explained spec requests stated the demolition was to be completed by July 1, 2018 with proper asbestos removal and disposal.

**Coopman** questioned what could be done if the July 1, 2018 deadline was not met and if something could be put in writing to enforce the deadline.

**City Attorney** informed we could have a written contract put in place to include a penalty clause in the event the demolition runs over the July 1, 2018, unless there is a catastrophic event. The contractor could be penalized for each day over the deadline. Everyone agreed on \$100 per day for the penalty amount.

### **MOTION: Rusch / McDermid**

Motion to award the contract for demolition work at 409 Cherry Street, using the city landfill to dispose of concrete disposal, to Landis Excavating LLC at the quoted amount of \$11,555.

**City Attorney** asked Nevin Landis if he was okay with the \$100 per day penalty clause in the contract.

Landis said yes, he was okay with this.

There was continued discussion regarding stump removal of 3 trees on the Cherry Street property. This was not addressed in the original specs when we went out for bids. City Attorney stated that the amount is small enough in which the City Administrator can make an amendment if given direction to do so by the Council.

#### **MOTION: McDermid / Coopman**

Motion to grant City Administrator Vicki Roberts permission to amend the contract with Landis Excavating LLC to include removal of three stumps from the 409 Cherry Street property.

A. Fire Department By-Laws.

Re: Fire Chief

Proposed change being made is as follows:

"Article X – Calls 10.1: A page or other notification, whether by dispatch or an officer of OFFD, will not be considered a call until dispatch has been advised that OFFD is in route to the scene. Roll call will not be taken if OFFD is cancelled prior dispatch being advised that OFFD is in route to the scene. Once in route, or when a required duty is completed, roll call will be taken."

**Fire Chief** explained the proposed change is being made to clear up any confusion when firefighters are being paged on calls. The Fire Department has reviewed and unanimously approved this change.

B. Temporary Class B License Application for the Panther Sponsor Group to sell beer on Saturday and Sunday, May 26 and 27, 2018 at Memorial Field Park in an area fenced in by the music bands at the North end of the football field during Memorial Weekend Celebration.

Re: Deputy Clerk

Deputy Clerk explained three bona fide clubs have filed application for a Temporary Class B License to sell beer at the Memorial Field Park during the Memorial Weekend Celebration. The city is only allowed to issue one license per premise. After lengthy discussions with the City Attorney and Department of Revenue (DOR) Tobacco and Alcohol Agent, it was concluded that we can issue three permits for this weekend at the park as long as each has their own designated area for sales and consumption and maintains their specific area. County Line Rod and Custom has fenced in the car show area in past years for their licensed premise and plans to do the same this year; Panther Sponsor Group has agreed to fence in the music band area for their licensed premise; and Panther Pride Association is asking for the entire park. We can have all three clubs fence in a specific area for their premise or we can have two clubs fence in a specific area and allow one to have the remaining park premise excluding the fenced in areas. The DOR Agent has recommended a map showing designation be attached to the approved licenses.
