OPPORTUNITY FOR CITIZENS TO ADDRESS THE COUNCIL - Citizens input will be limited to 3 minutes. Jeff Hoffman addressed the Council with regards to a letter he received from the city's building inspector informing him that he had to remove what he referred to as a decorative removable structure which he installed at the end of his driveway. Building Inspector Krozell indicated in her report that Hoffman was not compliant with setback or height restrictions when he installed two pillars at the end of his driveway. She also indicated that Hoffman informed the pillars were removable but she noticed concrete poured in the center. Hoffman did not obtain a building permit for this project. He was given seven days by the building inspector to remove the structure but wanted to come before Council to see if they could remain in place. The City has received complaints from two neighbors regarding the pillars being in the right away. Krozell extended the deadline until Sunday, October 14, 2018 at 5:00 PM to remove the structure; giving Hoffman time to express his views at tonight's meeting. Council did not take action on this item but did reiterate to Hoffman that he will have to contact the city's building inspector and become compliant with proper height and setbacks; even if that meant removal.
