### **Old Business:**

A. 100 year celebration.

Council President Wirtz gave an update on the 100 year celebration commemorative coin. The first batch of 200 coins should be in by the end of the week. The cost to us is \$9.95 per coin. We will sell each coin for \$20; with proceeds going to Memorial Field Park upgrades. Coins will come with a plastic sleeve but there will be an option to purchase a velvet or wooden box for an additional cost. Wirtz suggested we advertise coin sales in the Times Herald.

## New Business:

A. 2018 Annual Audit Report: Karen Kerber – KerberRose.

Karen Kerber stated the audit for the city and utilities went well. All information needed to complete the audit was provided upon request and balanced accordingly. Kerber presented and reviewed the 2018 Financial Audit Report prepared by her firm. Kerber noted the debt service and capital project funds have a negative balance. She suggested we address these issues and bring the accounts to a positive balance. As a whole the city and utility finances look good.

B. Revised Mayoral Committee Appointments.

C. Memorial Field improvements.

City Administrator Roberts and Mayor Rice met with School Superintendent Dean Hess and Jerry Moynihan to discuss issues with the hardball diamond at Memorial Field Park, to include the raised fence. Street Superintendent Magnin met with Fence Link today to discuss maintenance that is needed. Hess is hoping for a joint effort between the city, school, and Panther Pride Organization to all work together on the maintenance needs. He is also hoping we can continue using each other's fields without a lease in place. Mike Bouche from Panther Pride Organization felt that with a joint effort, things should get accomplished without having to spend any of the city's money. Man hours and equipment usage should be all that is needed from the city. He suggested we remove some of the old track to make the outfield right.

D. Operator's license application for Julianne Stewart.

Stewart has completed the Beverage Server Class and filed proper application with the City to obtain an operator's license. Chief Olsen completed a background check and signed off on her application.

E. New business requirements within city limits.

There is nothing in place for other businesses that are zoned commercial. He would like to see the city have more control over businesses entering the city. It was agreed this issue be sent to the Ordinance Committee for further discussion and recommendation.

F. Recycling Center Hours.

Street Superintendent informed the recycling center traffic diminishes significantly after 1:00 pm on Saturdays. He has checked with surrounding communities and only one other community has their center open all day. It was agreed to have recycling hours remain the same throughout the summer and discuss this issue again in the fall.
