### OPPORTUNITY FOR CITIZENS TO ADDRESS THE COUNCIL

Gerry Davis, who resides at 603 S. Main Street, expressed his concerns with the installation of the new sidewalk along S. Main Street. His concerns were mainly regarding his driveway and the line of vision with the retaining wall. He also explained significant water problems 30 years ago which have now been corrected and hoping the new sidewalk won't create water problems again. He also has concerns with lot line and right of way. Street Superintendent informed they are trying to keep the sidewalk uniform with being 3 feet off the curb. Street Superintendent, City Administrator, and Alderman Rusch will meet Davis at the site tomorrow to explain and answer any questions.

#### **Old Business:**

A. Update on dog park.

Emily Gonnering presented a final update. The dog park is coming along very well. A ribbon cutting ceremony is scheduled for August 17, 2019. Much progress has been made since the last update on fence installation. Fire hydrants for relieving areas, kiosk, poles for bag and ball dispensers, concrete slabs for benches, signs, and mulch have all been put in place. Emily is waiting on a tree from Corey & Co. along with a few small finishing touches.

#### **New Business:**

A. Offer to Purchase - 431 Union Avenue, Oconto Falls, WI

City Attorney drew up an offer to purchase for the Jamie Nelson property located at 431 Union Avenue with a purchase amount of \$31,200. The offer to purchase contingency is subject to approval by the City Council. Title insurance is just shy of \$500.

B. Resolution 19-007 to adopt a Citizen Participation Plan

OCEDC Director Paul Ehrfurth explained since the city is in the process of closing the Revolving Loan Fund; the city will need to return the remaining balance of funds plus the accounts receivable. The city can then apply for projects to be paid for from the funds that were returned. In order to apply for these funds, the State requires municipalities to adopt a Citizen Participation Plan. Projects being considered for the use of these funds are the Senior Center and blight elimination for part of downtown.
