At the November 14, 2017 Council Meeting, Guy Farvour spoke during the time in which citizens are allowed to address the council. At that time he informed Council that he was in the process of purchasing the property on Jackson Street in which the house was deemed inhabitable due to a problem with cat urine and feces, as well as a mold problem in the basement and attic. A raze order request was sent to Circuit Court and granted. The Circuit Court Judge gave judgment allowing Roberta Olshesky 30 days from October 19, 2017 to tear the house down or the city has the right to raze.

Guy Farvour informed he is now the new owner of this property, as they closed yesterday with the bank. His plans are to totally gut out the inside of the house and everything will be new when all is said and done. Farvour plans to do the renovations himself and hire contractors as needed.

Stuckey inquired what will be done regarding the mold and mitigation.

Farvour reassured he will have this checked out and evaluated as well. He will work with the health department and building inspector; providing weekly updates.
