City Ordinance 23-001 Direct Annexation of Oconto Falls School District Property to the City of Oconto Falls.

Public Hearing for Oconto Falls School District Petition for Direct Annexation Mayor Brad Rice called upon citizens of the community that had requested to speak. Concerns that were brought up

- Does the City have a twenty year plan and what do they plan on annexing in that plan
- Why wasn't the surrounding property owners reached out to
- Can any land possibly be retained for Town of Stiles
- If having to run new water and sewer down both sides of Columbia both sides should be annexed

The Cities twenty year plan covers three mile radius outside the city for future growth. Annexation by Unanimous Approval was used because Oconto Falls School District was the only owner of the property involved with the annexation. There is a three point test required by the state for annexation by unanimous approval. These points are

• Can the city provide sewer and water

- Is property contiguous to your property
- Dose it fit your twenty year plan.

All of these stipulations are met by the City. There is existing water mains down County Road I. Sewer is the only thing that would have to be determined.
