DISCUSSION AND POSSIBLE ACTION ON ANY OR ALL OF THE FOLLOWING:

Old Business:

1. Substation Budget Update

Kuhn discussed the bids that were received for the substation transformers; this is the largest variable in the project. The original substation project quotes came in at \$4.7 million. The updated substation project quote utilizing the current transformer bids came back at \$6.7 million. Kuhn explained the options available for moving forward with the project with ordering one transformer now and waiting to purchase the second versus ordering both transformers with staggered build dates. Kuhn suggested accepting the transformer bids for two transformers and paying 50% on one transformer at this time. The contract would be signed for the two transformers with the second transformer being built at a later date to separate manufacturing processes. Kuhn explained it has been 6 years since the last electric rate case and that through staffing reductions and efficiencies, the utility has been able to keep electric rates steady. Kuhn explained the substation project will necessitate a rate case. Kuhn discussed that rates are set off of the materials being installed, not off of how much the utility finances. WPPI performed a rate analysis and estimates that by moving forward with the \$6.7 million project financing, the electric

would be looking at a total of an approximate 12% rate increase over two years. The utility would use revenue bonds for the financing.

2. Transformer Bid Review with Possible Action
