

 - E. If a Member(s) is removed or recused under the law, the BOR may replace the member(s) or its remaining member(s) may hear the objection. No Fewer than three members may hear the objection.
13. Waiver Requests of the 48-Hour Notice of Intent to File Objection when there is good cause.
14. Requests for waiver of Board of Review Hearing, allowing Property Owners to file directly to the circuit court
15. Requests to testify by telephone or submit sworn written statements.
16. Hear Written Objections if notice was given by the Board of Review to the property owner and assessor at least 48 hours earlier, or both waive the 48-hour notice requirement.
17. Create a new hearing schedule for written objections filed but not heard.

 - A. Notify the owner or agent of the Board of Review's intend to review

 - C. Conduct the hearing according to procedures under state law (sec 70.47(8))
